Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>• Contact information (email, address and cell number)</li> <li>• Date of Birth</li> <li>• Social Security number</li> <li>• Income</li> <li>• Mortgage or Rent amount</li> <li>• Credit scores/Credit history</li> </ul> <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>

How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Wellfit chooses to share; and whether you can limit this sharing.

## What we do

**How does Wellfit protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

**How does Wellfit collect my personal information?**

We collect your personal information, for example, when you:

- Apply for credit or open an account with us
- Give us your income information or provide employment information
- Provide account information

We also collect your personal information from others, such as credit bureaus, affiliates or other companies.

**Why can't I limit all sharing?**

Federal law gives you the right to limit only

- Sharing for affiliates' everyday business purposes—information about your creditworthiness
- Affiliates from using your information to market to you
- Sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

## Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliates include nonfinancial companies, such as Wellfit Plans, LLC

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Nonaffiliates we share with include bank and nonbank lenders

**Joint Marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Wellfit doesn't jointly market

## Other important information

**For North Dakota customers.** We will not share personal information with nonaffiliates either for them to market to you or for joint marketing without your authorization.

**For Vermont customers.** We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
